

Impacto y pasajeros

En febrero de 2008, había 130 rutas de autobús que corrían a través de la Calzada Independencia y Gobernador Curiel, con un parque vehicular de más de 2,000 autobuses. La meta del BRT es reemplazar todos los autobuses a lo largo de la ruta que no sean BRTs. Algunas rutas serán eliminadas y otras serán alteradas para cruzar la ruta y servir como líneas alimentadoras.

Se espera que al iniciar servicio, la línea inicial contará con más de 174,000 pasajeros diarios. Esa cifra es más alta que la de pasajeros diarios del sistema del Metro de Guadalajara.

Se espera con esto tener un impacto favorable al medio ambiente, reduciendo la emisión de contaminantes; además de la mejora de la imagen visual de la ciudad.

Proyectos

Se pretende que antes de que termine la actual administración se tengan terminadas tres troncales más de este servicio.

La próxima en construirse y la más ambiciosa es la troncal diagonal, que conectará los centros de los cuatro municipios más importantes de la zona metropolitana de Guadalajara y correrá por carretera a Toluca, avenida Laureles, avenida Avila Camacho, Alameda, 16 de Septiembre y Avenida Revolución.

Otra será la troncal Juan Pablo II, esta línea transitará por avenida Juan Pablo II, Belisario Domínguez y Calzada González Gallo.

La última planeada será una continuación de la troncal Juan Pablo II y unirá la glorieta del Alamo con el aeropuerto Miguel Hidalgo, transitando por la carretera a Chapala.

0.PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.
